1. **Rishabh Traders;** - Three envelopes were received from Rishabh Traders; however, it was not clearly indicated to which material the Technical Bid and Financial Bid related. Therefore, in accordance with the decision of the committee members, the bid was not considered for inclusion in the tender evaluation process."
2. **Mulchand harde :-** Two envelopes were received from Moolchand Harde; however, it was not clearly indicated whether they related to the Technical Bid or Financial Bid for fruits or vegetables. Due to this lack of clarity, the committee members resolved not to consider the bid in the tender evaluation process.
3. **SU Enterprises :-** The Financial Bid and Technical Bid for fruits and vegetables submitted by SU Enterprises were found to be enclosed in a single envelope. Therefore, in accordance with the decision of the committee members, the bid was not considered for participation in the tender evaluation process."
